

ASSESSMENT

December 4, 1911.

Act of assessment on the property of the Catholic ratepayers of the parish of St. Gabriel of Valcartier, County of Quebec, made by the undersigned syndics in accordance with the ordinances of the Commissioners duly appointed to carry into effect the Chapter 1 of Title 9 of the revised Statute of the Province of Quebec, in and for the Roman Catholic Diocese of Quebec, dated April 26, nineteen hundred and eleven, in virtue of which ordinance the aforesaid syndics have been authorized to draw up an act of assessment to raise up on the ratepayers of the aforesaid parish, an amount of seven thousand, five hundred dollars and fifteen percent of this amount to agree with the law to defray the expenses of the building of the new stone church and repairing the old sacristy in the aforesaid parish of St. Gabriel of Valcartier, in the County of Quebec.

The said assessment being thirteen percent of the valuation roll, payable in twelve years, one payment a year.

At the request of Sieurs Robert Hayes, Michael Holton and Alfred Lepire, Trustees elected on the 2nd of April, nineteen hundred and eleven, to execute the Canonical decision of His Grace Mgr. L. N. Bégin, Archbishop of Quebec permitting the construction of a new church, for the Parish of St. Gabriel of Valcartier, and a new sacristy, as the actual sacristy cannot be conveniently repaired.

Alleging that they have conformed with our ordinance of the thirteenth of April, one thousand nine hundred and eleven, and relative to the confirmation of their election, that they are permitted to assess the proprietors of lands and other immovables situated in the said Parish.

We commissioners duly named for the ends of the first Chapter of the reformed Statutes of the Province of Quebec, dated 1909, in and for the Roman Catholic Diocese of Quebec, which has been Canonically erected in the Province of Quebec by the ecclesiastical authorities.

Considering that all the formalities our ordinance have been observed and the Trustees have made public their act of Election published in the notice required by the reimbursement of the premium, also that the immediate repayment of the Capital borrowed and interests notwithstanding the delays foreseen - by our ordinance.

~~This obligation cannot be reimbursed by part payments before the term agreed upon, unless by paying a further sum of three~~

Considering that no opposition has been encountered to the said demand of the Trustees, confirming and ratifying the said election and authorizing the said Trustees to assess the properties and lands and other immovables situated in the said parish of St. Gabriel of Valcartier, and to determine the amount of the sum for which each person will be assessed and place in order each one's part of the contribution, all to effect the said works and to ease the costs which they may occasion, the said act of assessment to be submitted to us.

Came and appeared: the Corporation of the Fabrique of St. Gabriel de Valcartier, body politic and incorporated, and here represented by Mister J. A. Aurilien Michaud, priest, Curé of the Parish of St. Gabriel de Valcartier and Secretary of the said Fabrique, following a resolution of the members of the said Fabrique, passed at a meeting held the twenty-fifth of May, one thousand nine hundred and eleven, of which a true certified, true copy is annexed to these presents and is acknowledged as true by the said J. A. Aurelius Michaud, and the undersigned Notary.

Present Mister Edouard Hamel, of Tewkesbury, farmer, hereinafter called the Lender.

All of whom agreed as follows:

1 - That the said Corporation acknowledge having received and to owe to the said Edouard Hamel the sum of three thousand dollars which they have borrowed from the latter;

2 - The debtor engage themselves to re-emburse the above mentioned sum, on demand, after five years, subject to a notice of three months, and to pay the Lender, interest at the rate of four percent annually, the arrears will also bear interest at the current rate and will be payable the 29th of June each year:

3 - to guarantee the re-embursement of the above mentioned sum, and its interest and any expenses of preservation and recovery, the debtor hypothecates specially in favor of the Lender, the following immovables to wit:

Lot No. two hundred and seventy-four of the Cadastre for the Parish of St. Gabriel de Valcartier, in the County of Quebec, with buildings and dependancies already built or will be built in the future:

4 - to adequately guarantee the re-embursement of the above-mentioned sum, interest and accesorics, the debtor engage themselves to insure and keep insured constantly against fire, in the name of the Lender, the buildings constructed on the immovables above mentioned for an amount of least three thousand dollars, and in default by the Debtor to do so, the Lender will do so at the expense of the Debtor, and he will

and he will have the right to repeat immediately all disbursements to this end with interest at the going rate of this loan from the day that they have been made;

5 - The Debtor, to guarantee all the expenses incurred in the recovery and conservation which may make the Lender and also the arrears with interest, interest upon interest on the property herein described for an additional sum of two hundred dollars.

6 - The Debtor will have the advantage of reimbursing the capital sum above mentioned in part payments not less than five hundred dollars, at the time of the expiry of the interest which will diminish at the same proportion annually.

7 - The titles of the fire insurance policies will remain in the hands of the Lender until full repayment of the loan;

In the year one thousand nine hundred and eleven, on the seventeenth of August,
Before Ls. Leclerc Notary Public undersigned, resident of the City of Quebec,
Came and appeared the Reverend Messire Aurelius Michaud, priest Curé Of the Parish of St. Gabriel de Valcartier, in the County of Quebec, acting by these presents for and in the name of the Trustees, duly named on the second of April one thousand ~~and ele one hundred and~~ nineteen hundred and eleven, duly authorized by a new ordinance of the Commissioners of the ~~Diocese~~ Roman Catholic Diocese of Quebec, and mouthpiece for the parish~~doners~~ of the said parish of St. Gabriel de Valcartier, for the necessary amount for the construction of their church, dated the 26th of April 1911.

The said appeared specially authorised to this effect by virtue of a resolution of the said trustees, dated the sixteenth of July last, one thousand nine hundred and eleven, annexed to the minutes of these presents, and ratified by letters of ratification of His Grace Monseigneur the Archbishop, L. N. Bégin at Quebec on the sixteenth of August current, one thousand nine hundred and eleven, thus appears ~~the~~ by the copy of authorization of the Trustees of the said Parish, certified by the Curé of the Parish and the original letter of Monseigneur the Archbishop of the Diocese of Quebec, annexed to the minutes of these presents.

Which Reverend Messire Aurelius Michaud in his quality above mentioned acknowledged to have confessed ~~and~~ to have legitimately owe to Dame Marie Tremblay, spouse separated of wealth of Sieur Napoleon Tremblay actually residing at Quebec, by these presents and accepting for herself the sum of seven thousand five hundred dollars, for as much as the said Dame Tremblay has loaned and delivered in good currency, to the said parish of St. Gabriel de Valcartier.

For which sum the said Reverend Messire Michaud promises and obliges to pay and reimburse the said Dame Tremblay, her heirs or assigns, from now until the end of five years and to pay her semi-annually interest at the rate of five percent, counting from this date.

The Reverend Messire Michaud declares that the said sum of the loan is to be completely used for the construction of the new church of the said Parish of Valcartier.

And for more security of reimbursement the said sum of seven thousand five hundred dollars & loan and interest, the said Reverend Messire Michaud in his above named quality obliges himself to ~~hel~~ keep the church of the said parish of Valcartier, insured against fire for the amount of the loan, and to transfer the insurance policy to the Lender, and to furnish her each year a receipt of renewal of same.

In default of which the said Lender may herself take out the said insurance to her profit and recover immediately from the Fabric the . . .

Two hundred feet (200' of eight inch (8") farm tile laid along the bottom of present open trench at the correct minimum grade of six inches (6") fall in one hundred feet (100') to flow on a same grade into a closed-joint eight inch (8") outfall sewer leading down to the river.

NOTE: The said eight inch (8")⁸ under tile is not to be connected to the standpipe tank.

I, the undersigned, Augustin Dufresne, Land Surveyor duly authorized to practice surveying in the province of Quebec, and resident of the City of Quebec, I traveled to lots 274 and 275 of the Official Cadastre for the Parish of St. Gabriel de Valcartier, in order to determine, establish and bound the line legally dividing the above-mentioned properties. I have seen the following titles:

Sale by the heirs of Robert Goodfellow to Alexandre Pageau, dated on the 23rd of February 1945, conferring to the latter, Lot No. 275 of the Official Cadastre of the parish of St. Gabriel de Valcartier.

Sale by Alexandre Pageau to J. Adrien Drouin, dated the 7th of August 1946, conferring to him a part of lot No. 275 of the said Cadastre.

La Fabrique of St. Gabriel de Valcartier is known to possess 274 of the said Cadastre.

While being company of the interested parties, the Fabrique being represented by three Trustees, Majella Murphy, Leo Corrigan and Marvin Douglas; Mr. Alexandre Pageau being represented by Kenneth McBain; and also by Mr. J. Adrien Drouin, I began the surveying.

I measured the width of lots 279-278-275 to the North-East extremity and also the South-West to find the points F and G, which connects with a straight line marking the line of separation of Lots 275, 274 and 269. From point A to point B, from point B to point C, from point C to point D, we verified the presence of the old fence which had been existing for more than thirty years. From point D to point E, the fence has now disappeared, but was quite visible in 1946 and was old at this date, more than thirty years.

I thus concluded that legally, that the line must be drawn according to this prescription.

I then left from point B and gave as a starting point from A-B I then drew a line B-C in (azimut) 3. 13' following from point B to point E the line of the old fence.

Replying to your request I went to visit your parish on October 9 last where I visited your presbytery.

This house which must be in existence for 50 years, consists of a cellar which is partly dug out, a ground floor comprising five rooms, a floor containing six rooms, plus a bathroom and a little attic.

The shape is that of a cross, the ground floor has 1390 square feet and the upper floor 1036 square feet. The wall of the foundation is of stone and mortar 24 inches thick; this wall is not in good shape. The cellar has no floor.

The structure of the house is in wood the outside covered with brick paper. The roof is of tin. The brick paper and tin have need of repairs. There are two doors of entry and nineteen windows of a French style; the condition of the windows is bad; the wooden gallery in the front is also in a bad state.

On the inside the floors are of wood covered with linoleum and are not level. All the finish of the walls and ceilings are of wood, except in the kitchen where the finish is "Donnacona".

The plumbing consists of a bathroom and a toilet and the kitchen sink; the water comes from a well.

The heating comes from a furnace which burns wood placed in the cellar with air vents in the floor.

The presbytery is situated in a nice location, the driveway and sidewalk are in good condition.

The general quality of this building is poor. The walls are only six inches thick and are probably made with 2x4s inside and outside. The general appearance is good enough; by repairing the gallery and the brick paper and by painting the roof and the exterior wood, the whole would look relatively good. The interior is clean.

However, to give the occupants a minimum of comfort, in my opinion the following must be done:

- a) Repair or change the windows so that they should fit tightly and also that they should open and close normally.
- b) Install a central heating system fueled by oil with radiators.

C) Install a new bathroom, or at least a half bathroom (lavabo and toilet only)

It is difficult to judge if such repairs are justifiable because as mentioned above the quality of this construction is low. It all depends on the needs of the parish. In other words, does the parish of St. Gabriel of Valcartier need a presbytery of 2430 square feet the whole comprising twelve rooms.

It is understood that for such reasons it would be more economical to repair the existing structure than to rebuild. On the other hand if a surface of 1400 square feet would be sufficient, I believe that a new presbytery would be more economical over the long haul when we keep in mind the maintenance and heating.

A new presbytery would also be more comfortable, and of better appearance because a finish of brick paper is not so very pretty to my taste.

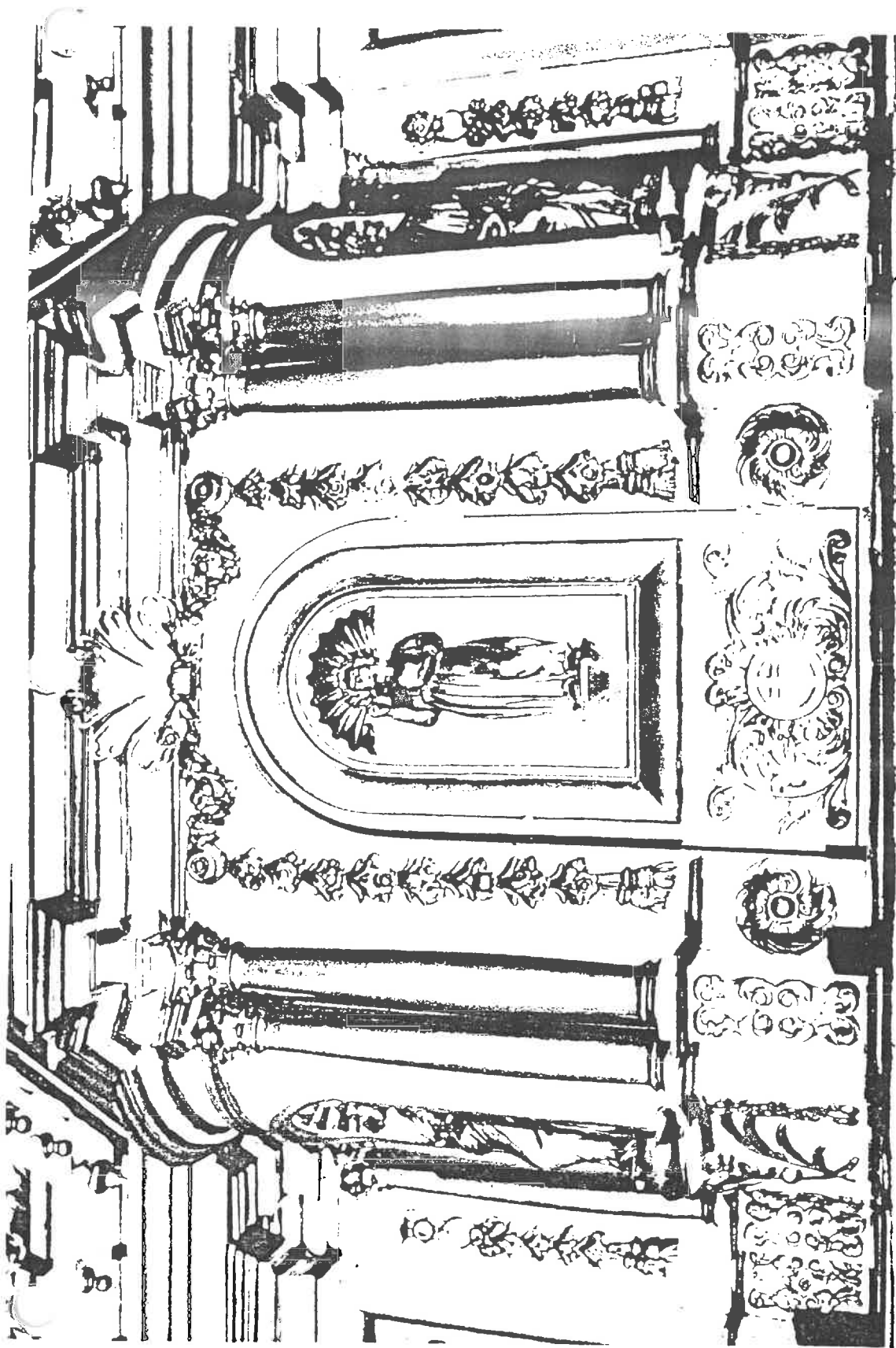

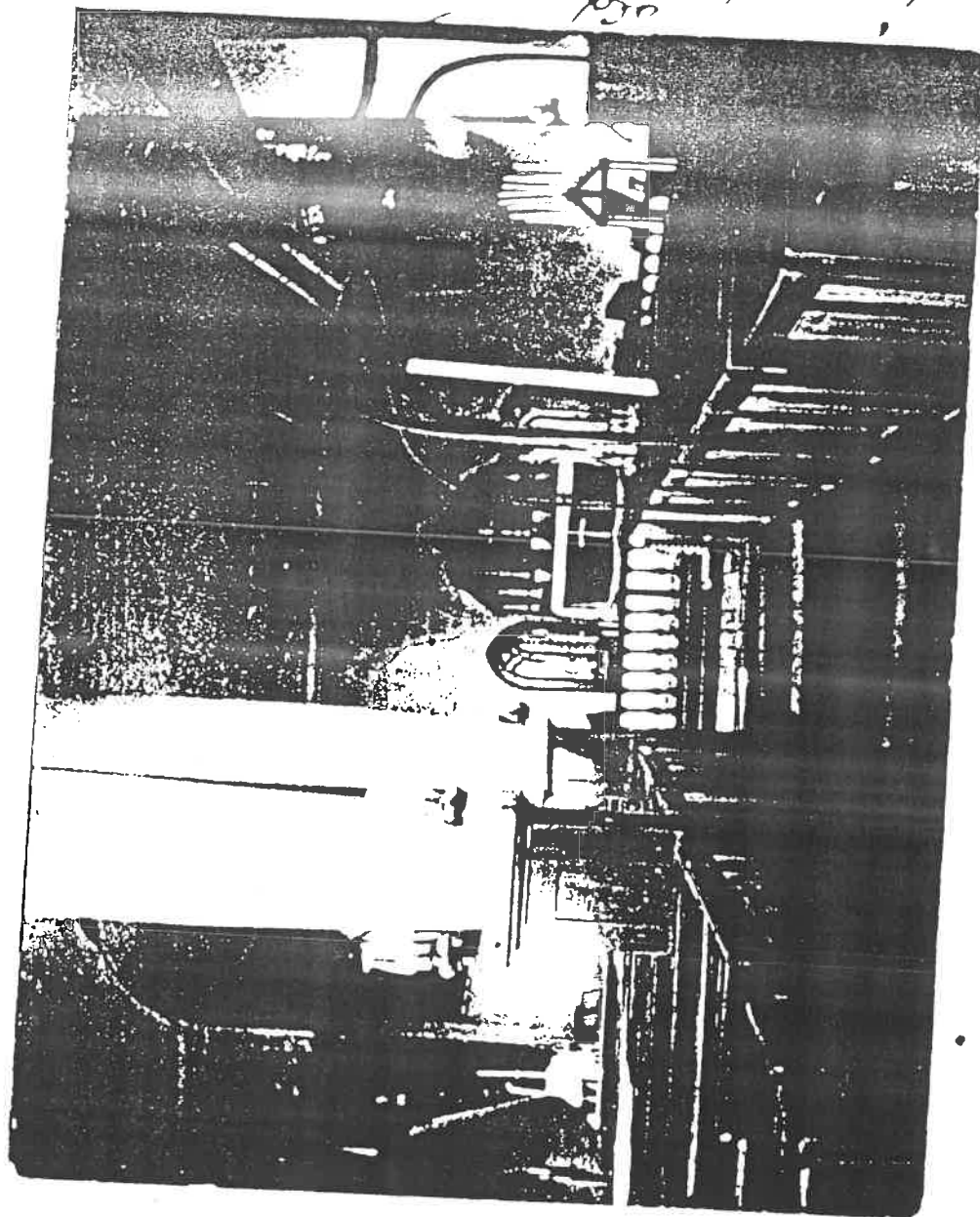

The above stable was sold to George Murphy on May 11, 1952, by a resolution adopted by the church wardens for the sum of \$150.00. It was dismantled shortly after.



The above picture depicts the front of the tabernacle of the altar of St. Gabriel's Church, Valcartier Village. It is a work of ancient art by the famous sculptor, François-Noël Levasseur, 1703-1794. It was taken from an ancient church in St. Foy, which was partially destroyed by General Murray, on April 25, 1760. The Holy Family, St. Joseph and the Blessed Virgin are in the niches on either sides of the tabernacle. This is one of the oldest sculptures of the Holy Family known in Quebec. The altar was installed in the primitive chapel of Valcartier in the early 1830's.

This photo depicts the interior of St. Gabriel's Church, Valcartier. This church was built in 1852 and replaced by the new church in 1911. The picture was taken in 1909 and contributed by Mrs. S. Clendinneng, R. R. 2, Apple Hill, Ont., K O C 1 B O. Remark the oil lamps on the sides of the columns, also the stove pipes running the length of the church, and the supports of the chimney.

This picture shows the door of the tabernacle of the altar of St. Gabriel's Church, Valcartier. It is made of bronzed wood and white paint, 49.5 X 26 cm. (the Monstrance) 20.3 cm. (the Child Jesus).

The tabernacle of St. Gabriel de Valcartier is the only one where the Infant Jesus appears between his parents. Standing on a tiny pedestal, the upper part ornamented by a shell. Beneath appears a cross in the middle of a sun, surrounded by foliage.

The figure of the Infant Jesus ^{above} on the door of the tabernacle is looking straight ahead. He is holding in His left hand a globe surmounted by a cross and His right hand is raised in a gesture of benediction. It is customary to see the Infant Jesus of the Globe in the arms of his Mother. It is rare indeed to find Him alone.

Devotion to the Infant Jesus of the Globe was introduced into New France by the Jesuits in the XVIIth century. It will be noted that the decor of the tabernacle is of Jesuit inspiration.

This devotion was replaced by the middle of the XIXth century by devotion to the Infant Jesus of Prague. In both these statues - the Saviour of the World is presented as a child whose purity overcomes the forces of evil.
